Sir,

With reference to the letter cited above, the Commission advertised for the post of Assistant Professors in various disciplines of Oncology under H&FW(B) Department and interviewed candidates discipline-wise with the help of Experts/Advisers deputed by the Govt. and recommended the candidates discipline-wise, in order of merit:

(i) **Assistant Professor of Medical Oncology**

No. of candidate: 1, No. of posts-3, Reservation: OC-1 & OBC/MOBC-2

The Commission has recommended the following candidates for recruitment to the post of Registrar of Medical Oncology under H&FW(B) Department, in order of merit:

Only one candidate namely Dr. Damodar Das (Roll No.0000001) appeared in the interview. However, on perusal of the experience of the concerned candidate, it could be found that the candidate did not possess the requisite qualifications. Hence, according to the Expert Dr. Debabrata Goswami, Prof. & HoD of Medicine, GMCH, the candidate could not be recommended. The said expert has also endorsed his opinion in writing to that effect **(copy enclosed)**.

Accordingly, the Commission could not recommend the candidate to the aforesaid post, for the reasons stated above.

(ii) **Asstt. Professor of Radiation Oncology**

No. of candidates: 3, No. of posts-3, Reservation: OC-1 & OBC/MOBC-2 (RFW-1)

The other two candidates namely Rabin Saikia (Roll No.0000001) and Gitanjali Barman (Roll No.0000002) appeared in the interview. However, on perusal of the experience of the concerned candidate, it could be found that the both the candidates did not meet the requisite qualifications. Hence, according to the Expert Dr. Gautam Goswami, Prof. of Radiation Oncology, Cancer Hospital, GMCH, the candidates could not

be recommended. The said expert has also endorsed his opinion in writing to that effect **(Copy enclosed)**.

Accordingly, the Commission has recommended only GAUTAM SARMA (Roll No.0000005) but could not recommend the other two candidates to the aforesaid post, for the reasons stated above.

(iii) **Asstt. Professor of Surgical Oncology**

No. of candidate: 1, No. of posts-3, Reservation: OC-1 & OBC/MOBC-2 (RFW-1)

One candidate Rupjyoti Borthakur (Roll No.0000001) appeared in the interview. However, on perusal of the experience of the concerned candidate, it could be found that the candidate has no exposure in oncological part of the General Surgery, Gynaecology urology etc. and has exposure of ENT and head-neck surgery. Onco-surgery involves care of oncology cases of all the branches of surgery. Hence, according to the Expert Dr. Ranjit Kumar Deka, Professor, Deptt. of Surgery, GMCH, the candidate could not be recommended. The said expert has also endorsed his opinion in writing to that effect **(Copy enclosed)**.

Accordingly, the Commission could not recommend any candidate to the aforesaid post, for the reasons stated above.
