Sir,

With reference to the subject cited above, I am to inform you that the Commission advertised for the aforesaid post under H&FW(A) Department on 02.04.2015 vide Advt. No.08/2015 and interviewed the candidates on 18<sup>th</sup>, 19<sup>th</sup> and 22<sup>nd</sup> March, 2016.

In the meantime, the Commission had decided to cancel the declaration of results of interviews for the said post which were earlier held as stated above, in pursuance of the legal opinion of the learned Advocate General, Assam vide his letter No.AGL.46/2016/128 dated 6.3.2017 and the subsequent decision of the Commission in its meeting held on 07.03.2017 followed by an official Notification No.136PSC/DR-2/1/2013-2014 dated 8<sup>th</sup> March, 2017. Accordingly, the Commission conducted fresh interviews for the aforesaid posts on 15<sup>th</sup>, 16<sup>th</sup>, 17<sup>th</sup>, 18<sup>th</sup> & 20<sup>th</sup> March, 2017 with the help of experts/advisers deputed by the Government of Assam and recommended the following candidates, in order of merit:
