1.4. As on March 31, 2012, the strength of the staff in the Commission was 197 out of which 36 were Gazetted and 161 were non-Gazetted. Appendix I contains the details of the sanctioned staff of the Commission during the year under report.

FUNCTION:

1.5. The Assam Public Service Commission has to discharge the duties and functions Article 320 specified in ofthe Constitutions. The Commission is required to advice Government on all matters relating to framing of Recruitment Rules, Principle to be followed in making appointments, promotions and in respect

of disciplinary matters affecting Civil Servants. Recruitment to the Assam Civil Service and other allied categories are made through the combined competitive (Preliminary and Main) Examinations. The Assam Public Service Commission is required to be consulted in the matters of recruitment, promotions; Disciplinary matters, framing of Recruitment Rules and other Service matters of the Assam State Services (Namely ACS, APS, AFS, AESS, Ranger course in Forestry, B.D.O. etc). The Commission is also to be consulted in respect of appointment to certain categories of posts of Municipal Corporation of Assam and some other organizations under the provisions of Article 321 of the Constitutions.

FINANCIAL MATTERS:

1.5. The Commission Derived an income of Rs.59,865/-(fifty nine thousand eight hundred sixty five) only. The main source of income was mostly from various application fees, Examinations Fees etc. in connection with the various post advertised.

The expenditure of the Commission was Rs.6,56,10,819/- (Six crores fifty six lakhs ten thousand eight hundred nineteen) only. Details information relating to financial receipts and expenditure during the year 2011-12 was shown in Appendix-II.

ACCOMODATION:

1.6. The Secretariat of the Commission is located in its own building (incomplete) at Jawaharnagar, Khanapara, Guwahati - 22.

Number of candidates recommended during the year depends upon the vacancies intimated for those Examinations whose results are declared during the year.

RECRUITMENT BY EXAMINATION:

1.9. 2(two) Exam. was held during the year 2011-12. In the previous year i.e. 2010-11, no exam was held.

Despite time and resource limitations the Commission was able to held various Examination as per schedule.

DIRECT RECRUITMENT BY INTERVIEW:

1.10. During the year the work load in respect of number of applications received for recruitment by interview has revealed a upward trend to that of the previous year 2010-11. The number of applications received in 2010-11 was 3580 and as against 6071 numbers of applications received in 2011-12.

RECRUITMENT RULES AND DRAFT SERVICE RULES:

No. Recruitment Rules and Draft Service Rules were referred to the Commission during the year under report.

PROMOTIONS:

1.12. In promotion cases 284 officers were recommended in 2011-12 as against 493 in the previous year 2010-11. (Details at Chapter-V).

DISCIPLINARY AND APPEAL:

1.13. All together 22(twenty two) cases were received by the Commission during the year under report (2011-12). And all of them were disposed off by the Commission during the year Government accepted Commissions advice in 9(nine) cases during the year under report. (Details at Chapter-VI).

EXTRA ORDINARY PENSION CASES:

1.14. No. extra ordinary pension etc. cases were referred to the Commission during the year under report.

DELAYED OFFER OF APPOINTMENT:

1.15. It comes to Commissions notice that the offer of appointment to candidates

recommended by them on the basis of written Examination/Direct Recruitment by the interview and in case of Promotions were delayed in several cases by the concerned departments during the year under report. (Details in Appendix IV).

EXAMINATION WINGS:

1.16. The Commission is continuously engaged in pre-interview programmes for various posts and also reviewing the examination and interview methodology and other allied matters. The Commission has introduced objective type tests in many of their Examination for which a "Question Item Banks" in various discipline is maintained confidentially for utilization, in case any such need arises.

SYSTEM:		

1.17. The Intelligent Character Recognition (ICR) based Examination Automination System of the Commission was inaugurated by Shri Tarun Gogoi, Hon'ble Chief Minister of Assam on 24th Feb/2011.

This system automates every step of existing examination process right from processing of application to preparation of result sheet and will place checks in every step to eliminate common errors.

The system has the intelligence of verification and validation of each record with less human intervention, making it an error free unbiased process. Also the time taken by the system is much lesser than the manual processing.

The installation of the above system based on advanced technology would go a long way to further the cause of maintaining high degree of transparency and professional efficiency of the Commission.

1.18. The total number of application received shown in correspondence column does not tally with the total number of application received for recruitment by Examination and Interview is due to the fact that Examinations and Interview could not be held for all the posts advertised during the year.

CHAPTER-II

RECRUITMENT BY EXAMINATION

A. GENERAL OBSERVATION ON THE METHOD OF RECRUITMENT THROUGH EXAMINATION:

Revision of scheme and syllabi for combined competitive (Main) Examination.

2.1. In order to take into account new developments the Commission has adopted a continuing process of reviewing the selection process. The Scheme and syllabi Combined Competitive (Main) Examination were received by the Commission in consolation with academic experts. The revised Svllabi for Combined Competitive Examination have been in corporate in the rules of the Combined Competitive Examination.

NEED FOR PROPER ASESMENT OF VACANCIES:

2.2. The Commission regrets to state the in spite of repeated observation made by them in their earlier reports, cases continued to occur where some of the Departments did not intimate the actual number of vacancies for being included in the Commission's notice of the Examination/Interviews for information of the perspective candidates. As a result in respect of some of the Examinations/Interviews the number of vacancies notified initially in the notices issued by the Commission did not bear resemblances to the number of vacancies finally reported for being filled on the result of those Examinations/Interviews.

USE OF INDIAN LANGUAGE IN COMBINED COMPETITIVE (MAIN) EXAMINATION:

2.3. In the Combined Competitive (Main) Examination the candidates have to answer in the medium of English in all paper including general studies.

However those candidates who opt to write in Assamese in Optional papers are also allowed to do so.

EXAMINATION WINGS:

- 2.4. The conduct of various competitive Examinations for selection to various services and posts being one of the principal activities of the Commission. Great importance is attached to the quality, efficiency and reliability of the Examination process. This necessitates a constant monitoring of the Examination process, methodology and allied matters. To facilitate this, an Examination Confidential Wing has been set up by Commission. The Commission maintains contact with other recruitment agencies, academic experts concerned with a view to keep abreast of the latest Development in Assam and else where in the field of Examination.
- 2.5. The Examination confidential Wing has been instrumental in enabling the Commission to switch over smoothly from the conventional essay type to objective type papers in the Combined Competitive (Pre.) Examination etc. This has helped the Commission to cope with the phenomenal increase in the aforesaid Examinations besides ensuring total objectivity in the evaluation process and timely declaration of result.

B.EXAMINATION HELD DUTING THE YEAR:

2.6. The Commission held two (2) Examinations for recruitment to the various posts and services during the year. (Appendix –III)

SALIENT FEATURES OF DIFFERENT EXAMINATION:

2.7. The Half-yearly Departmental Examination for officers belonging to IAS/ACS etc. and various officers of other Departments held form 17th Feb/11 to 21st Feb/11 in 4(four) centers, viz-Guwahati, Jorhat, Tezpur and Silchar. The Tribal Language Examination i.e. Bodo, Karbi, Mishing, Dimasa, Khasi, Kuki, Garo and Hmar were held on 27th Feb/11 at Guwahati centre only. Altogether 950 officers applied for appearing in various subjects for the said Examination. The results of both

Examinations were announced on 15th Dec/11 separately. 482 officers passed in various subjects and 77 officers in Tribal Language.

FINANCE AND ACCOUNTS OFFICERS/TREASURY OFFICER EXAMINATION (DEPARTMENTAL PROMOTION):

The Commission held written Examination on 6/11/11 for recruitment to the post's of FAO/TO (Departmental Promotion) under Assam Finance Service Deptt. Out of 114 applicants who responded against the advertisement, 90 applicants (GENL-51,SC-11,STP-8,STH-03,OBC-15,MOBC-02) found eligible for the Examination, 73 (GENL-40,SC-10,STPcandidates 07,STH-03,OBC-12,MOBC-01) actually appeared at the Examination 32 candidates (GENL-20,SC-03,OBC-08,MOBC-01) recommended by the Commission. But appointment notification received during the year under report.

AUDIT OFFICER EXAMINATION:

2.9. The Commission held written Examination from 26/10/2010 to 29/10/2010 for recruitment to the posts of Audit Officer under Assam Local Fund and Audit Deptt. Out of 120 applicants who responded against the advertisement 113 applicants (GENL-61, C-14, STP-14, STH-02, OBC-21 and MOBC-01) were found eligible for the Examination. 111 candidates (GENL-61, SC-14, STP-14, STH-02, OBC-19 and

MOBC-01) were actually appeared at the Examination and 81 candidates (GENL-46, SC-10, STP-08, STH-02, OBC-14, MOBC-01) recommended by the Commission. But no appointment notification was received during the year under report.

C. DELAYED OFFER OF APPOINTMENT TO THE CANDIDATES RECOMMENDED BY THE COMMISSION THROUGH EXAMINATION:

2.10. In 2(two) cases of Examination, offer of appointment to the candidates recommended by the Commission were delayed by Government.

The Commission recommended 32 Nos. of candidates against 37 Nos. of posts of Finance Service Deptt. and 81 Nos. of candidates against 85 Nos. of posts of Assam Local Fund and Audit Service Deptt.

D. MATTERS RELATING TO CANDIDATES BELONGING TO OBC/MOBC/SC/STP/STH.

2.11. The Commission was able to recommend the requisite number of candidates belonging OBC/MOBC/SC/STP/STH against most of all vacancies reserved for them. The Statistical breakup of various Examination conducted by the Commission during the year under report are given in details at appendix-VII.
