Terms and conditions:

- 1) Assam Public Service Commission intends to dispose of old furniture and fixtures by the way of auction in the office premises of APSC, khanapara, Guwahati-22. The list of old furniture and fixture has been attached at **Annexure –III**.
- 2) Bidders interested in purchasing these items may attend and quote their rates in sealed envelope as per the enclosed proforma at **Annexure-I** (particulars of bidders) & Annexure-II (price bid) super scribe as "Auction Bid at APSC, Khanapara", addressed to the Secretary, APSC Khanapara, Guwahati-22 on or before **15/09/2023** till 03.00 P.M. the bids will be opened on the same day at 03.15 P.M.
- 3) The old furniture items will be disposed of on "as is where is basis" and no guarantee for its worthiness or quality will be given by the Commission.
- 4) The Price bid will have to be submitted as per Annexure-II.
- 5) Interested bidder can participate in the bid for the whole item available in the Annexure-III. No bidders will be allowed to bid for single item. The whole available furniture items will have to be purchased by the bidders as per Annexure-III. **The Minimum bid value for the available furniture items is Rs.26,850.90 excluding GST.**
- 6) An **EMD amount of Rs.1000/- (One thousand) only** have to be submitted with the bids as Demand draft drawn in favour of "**Secretary, APSC**" payable at Guwahati. Bids without Earnest Money Deposit will not be considered and shall be rejected.
- 7) The EMD amount will be released after completion of the bid process.
- 8) The bids will be evaluated for the total items and highest evaluated bidder will qualify for the bids within the terms and conditions incorporated in this bid document.
- 9) The successful bidder required to deposit the bid amount by the way of Demand draft drawn in favour of "Secretary, APSC" and Payable at guwahati within 10(Ten) days on the finalization of the bid.
- 10) Interested bidder may visit the office of the Assam Public Service Commission, Khanapara, Guwahati-22 during office hours from **07/09/2023 to 14/09/2023** for inspection of the auctioned items.
- 11) The auctioned materials shall have to be removed by the successful bidder at the bidder's own expenses within 7 days of depositing the bid amount. The Assam Public Service Commission will not be responsible for any transfer of the auctioned furniture to the successful bidder.
- 12) The Bid amount is **excluding GST**, as the GST is to be paid by the recipient of the goods as per the rates applicable.
- 13) The bidders should submit documentary evidence in support of the identity and residential status (PAN Card, ID proof etc. in case of individual and Registration Certificate and GST registration/PAN card in case of firms).
- 14) No revision or correction of rates shall be allowed after submission of bids.
