RE-AUCTION NOTICE

Subject: <u>Disposal of condemned Government vehicles-Reg.</u>

Office of the Assam Public Service Commission, Jawaharnagar, Khanapara, Guwahati-781022, is proposing to dispose off 2 (Two) condemned govt. vehicles on "as is where is basis". Details of the said vehicles are as under:-

- 1. Accordingly, sealed quotations affixing court fee stamp of Rs.8.25(Rupees Eight and twenty five paisa) only are invited for disposal of the said vehicles on the terms and conditions mention below. Person/firms, interested in purchasing the above mentioned vehicles, may submit their highest bid in the enclosed Proforma in a sealed cover addressed to the undersigned latest by 3:00 PM on or before 06/06/2024 at the Office of the Assam Public Service Commission, Jawaharnagar, Khanapara, Guwahati-781022, and will be opened on the same day at 3:15 PM. The bidder or their representatives, not more than one for each quotation, may be present, if they so desire, at the time of opening of Quotations. The cover should be prominently superscripted with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLES".
- **2.** The vehicles will be available for inspection between 3.00 PM to 4.00 PM from **14/05/2024** to **05/06/2024** in presence of the In-Charge, Pool, APSC.
- 3. The Auction of the said vehicles will be governed by the following conditions:-
- i. The vehicles will be auctioned separately for each vehicle, not through drawl of lot.
- **ii.** The vehicles will be sold on "<u>as is where is basis</u>". The auction process will be conducted in presence of the constituted Condemnation Board.
- iii. The bidders are required to pay Earnest Money of Rs. 2000.00 (Rupees Two thousand only) for each vehicle.
- iv. Earnest Money is payable by means of Demand Draft drawn in favour of "Secretary, APSC". (payment by cheque or cash shall not be accepted)
- **v.** Quotations received without demand draft towards Earnest Money will not be considered and shall be rejected.
- **vi**. The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of Secretary, APSC.
- **vii.** The Earnest Money of the successful bidder will be released only after the deposit of the bid amount. Earnest Money will not be adjusted as bid amount and will be forfeited, if he fails to honour the bid. In case of failure to deposit final bidding amount, the respective vehicle may once again be taken up for re-auction.
- **viii**. On submission of application by the unsuccessful bidder EMD will be refunded after completion of the process.

- **ix.** The delivery of the auctioned vehicles will be arranged only after the successful bidder submits documentary evidence in support of the residential status (PAN Card, ID proof etc. in case of individual and Registration Certificate etc. in case of firms).
- **x.** The auctioned vehicles will be removed by the successful bidder within 02 working days of depositing the bid amount, at their own expenses.
- **xi.** The vehicles will be disposed off on "as is where is basis" and no guarantee for its worthiness or quality will be given by this department.
- **xii.** This Department will not owe any responsibility for transfer of vehicles and for any other liability for using these vehicles for commercial or any other purpose after sale.
- **xiii.** The successful bidder will also be responsible for getting Registration Certificate of the Vehicles and/or any other documents as required by the RTO, in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
- **xiv**. The bidder will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.
- **xv.** The Bid amount is excluding GST, as the GST is to be paid by the recipient of the goods as per the rates applicable.
- **xvi**. The Board reserves the right to accept or reject any/all of the quotation without assigning any reason.
