In continuation of this office Notification No.39PSC/E-1/2023-24 Dated Guwahati the 29th April, 2023, it is for information to all concerned candidates that the **Combined Competitive (Main) Examination, 2022** will be held on **8th, 9th and 10th July, 2023** at **7(seven) Zones** viz. **Silchar, Jorhat, Nagaon, Tezpur, Lakhimpur, Bongaigaon and Guwahati.**

Therefore, the candidates to the said examination are hereby directed to select the Zone from the 7(seven) Zones mentioned above in the link provided on the home page of the Commission's official website, www.apsc.nic.in to be made effective from **8th May, 2023** to **14th May, 2023** by logging in with their respective **user Id** and **password**. The candidates should further note that:

- (i) Candidates, who fail to select the zone, will be accommodated in Guwahati zone only.
- (ii) If the number of candidates are found to be less in any of the zones as per the opinion of the Commission, such candidates will be accommodated in Guwahati zone.
- (iii) Examination zone once selected shall not be changed.
- (iv) No request shall be entertained for allotting zone after the last date.
